REGULATIONS: If you do not abide by the following regulations, it is considered an offense and are at risk of a misdemeanor and up to a \$500.00 fine per offense for each day that you are in violation of Ordinance 150. See annettatx.org – Government – Ordinances for more details.

Every person that will solicit in Annetta will be required to register at Annetta Town Hall. Solicitors will be required to show a valid state or federal issued identification card. Once permit is issued, each solicitor shall wear and display their permit tag, which shall not be transferred to another person. Show the permit when challenged by Law Enforcement, Town of Annetta employee or any citizen to whom they are soliciting to.

Solicitor's hours are from 8:30 am – 9:00 pm. Any home with a posted No Soliciting/No Trespassing sign located in a conspicuous place shall be avoided. No aggressive soliciting. You must leave if requested to do so. May not solicit from a vehicle, right-of- way, and do not impede the flow of traffic.

Agreement: I have read the above statement and agree that I will abide with the terms of Annetta Town Ordinance 150 regarding guidelines for solicitors in the Town of Annetta. Town of Annetta reserves the right to revoke or suspend the permit at any time and shall be surrendered to the aforementioned authority upon request. Furthermore, I understand solicitors will solicit at their own risk and will release any liability against the Town of Annetta should any solicitor incur any type of injury, illness or disease while soliciting within the Town of Annetta.
